Dear Seymour School Community,

We hope this communication finds you all safe and well. At the December 18, 2020 Special Board of Education meeting, Seymour Schools shared a plan designed to safely introduce increased numbers of students for in-person learning in a progressive manner. As you know, our numbers unfortunately increased, which caused a halt to our original phase 2 start date. However, we have been constantly monitoring our internal health metrics as well as our town health metrics and are pleased to say that we have seen a decrease, which allows for us to readdress the opening of our schools.

As previously shared, the team held the following goals in the forefront of all discussions:

- Maintain safety of staff and students
- Increase student and teacher in-person contact

It is very important that we share what this means for social distancing for a full return for our K – 5 students if all students opt to return. This would mean that instead of having an average of 6 feet of social distancing as we have in our in person hybrid learning model, we would now have an average of 2 feet (some rooms may be 1.5 feet, while others may be up to 3 feet) in our K – 5 classrooms. This also means that our busses will be full in most cases as well as our cafeteria/classroom lunches. Should an exposure occur in one of these fuller classrooms, please realize that the whole classroom would potentially have to quarantine. We will continue to assess each situation with the Naugatuck Valley Health District.

In consultation with our team of administrators and teachers, a bifurcated approach is the most prudent approach at this time in order for us to safely and confidently move forward to bringing our students back. This means that we will first invite our K – Grade 2 students to return on February 22, 2021, then we will invite our Grade 3 – Grade 5 students to return on March 8, 2021.

We understand that the reduced social distancing may cause some parents to reevaluate their decision to send their children back to school. This is why we need for you to let us know as soon as possible if you are electing for your child to not return for in-person learning. If you do not want your child to return to full in-person learning, please email your child's school building administrator that you are requesting temporary full distance learning and include Mrs. Tencza (vtencza@seymourschools.org) and Mrs. Cathy Guerra (cguerra@seymourschools.org) on that correspondence by no later than Thursday February 18, 2021 for our K – Grade 2 students and by no later than Thursday March 4, 2021 for our Grade 3 – Grade 5 students. This is needed so that our administrators and teachers can plan to welcome our students back.

Once we return to full in person learning, students who have been with their temporary full distance-learning teachers since the fall and who wish to remain temporary full distance learners will remain with those teachers. These students will not be able to re-enter until April 19, 2021, which is the midpoint of the last marking period. The only two options for families moving forward will be either fully in-person or temporary full distance learning with your child's current teacher. There will no longer be an in



person hybrid learning model. Students will learn in person five days a week or will learn remotely five days a week.

Please review the chart below which outlines our target dates provided we continue on a positive trend in terms of our health metrics.

Phase 2: Target dates:

-February 22- **K- 2 schools welcome all students back for in-person learning.** At this point, it is anticipated that all K – Grade 2 students are back in-person learning with the exception of those opting into the temporary full distance-learning model.

Please note that any Grade 3 – 5 siblings of our K – 2 students will also be allowed to return on February 22.

All other **Grade 3 – Grade 12** schools will continue their hybrid learning days in a 3:2 rotation. Please view the color-coded calendar on our website.

-March 8 - **3- 5 schools welcome all students back for in-person learning.** At this point, it is anticipated that all Grade 3 – Grade 5 students are back in-person learning with the exception of those opting into the temporary full distance-learning model.

All other **Grade 6 – Grade 12** schools will continue their hybrid learning days in a 3:2 rotation. Please view the color-coded calendar on our website.

Phase 3: Tentative Target date:

-April 12 - **6-12 grades welcome all students back for in-person learning.** At this point, it is anticipated that all students are back in-person learning with the exception of those opting into the temporary full distance-learning model.

Families must continue reporting to building administration or the district nurse all COVID-19 cases and quarantines during the coming weeks. This information is critical for us to ensure a safe reopening. In order for the target dates to occur, our partnership with NVHD and any state/government guidelines at the time would confirm the safety of allowing these to occur. Please realize that any significant increase in our metrics may halt this plan at any time. This will continue to be communicated from Central Office.
